
Since the closure of the youth centre, Staffordshire County Council have agreed temporary uses by local charities & community groups under formal leases or licenses which have now all ceased.

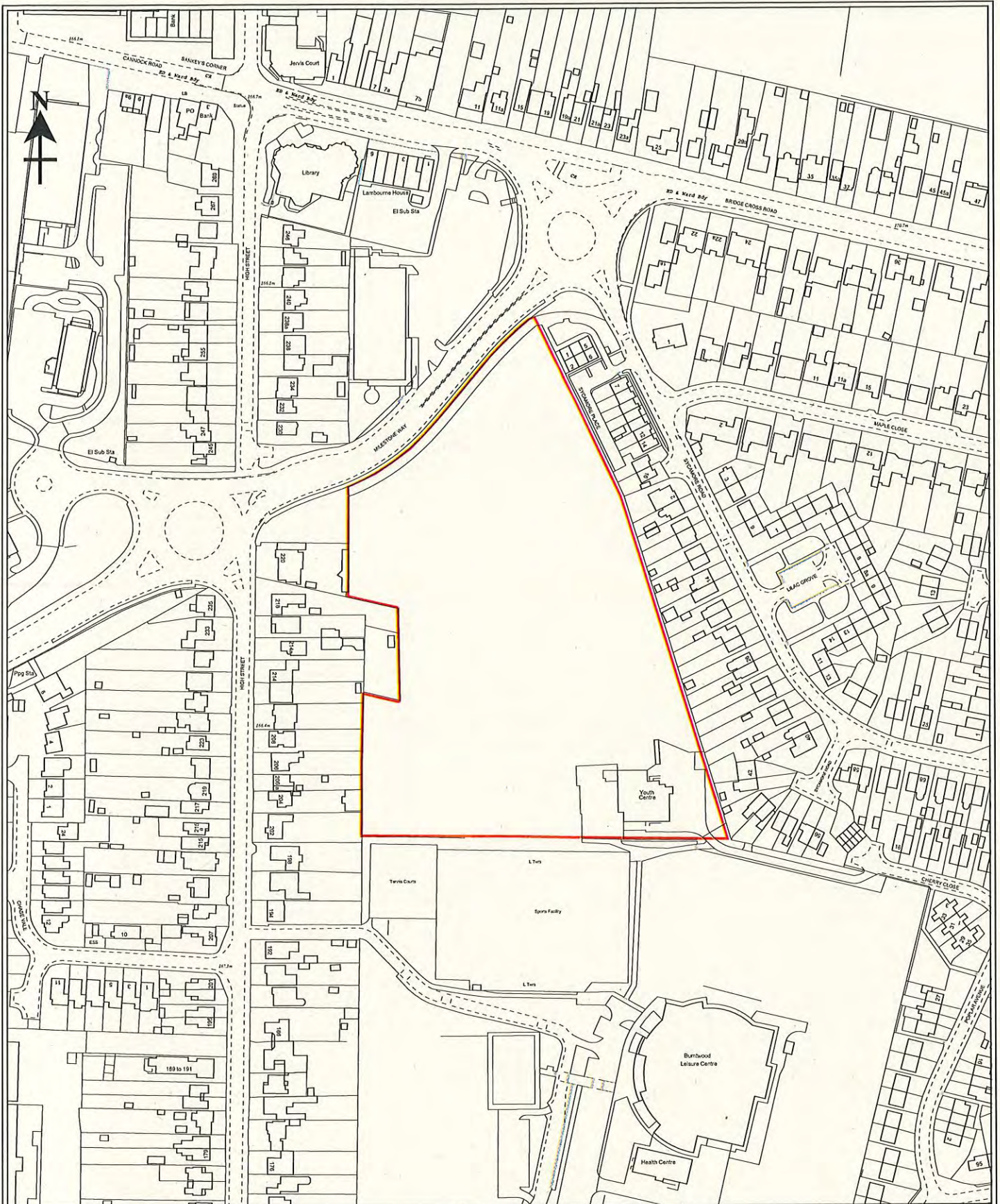
